c. Other incidents

There has recently been an increase of incidents of anti-social behaviour elsewhere within Ormesby and Hemsby, particularly within the last 5 weeks. The main problem has been youths knocking on doors and running away. Officers have stopped and spoken to 27 youths during the last two weeks who have been in the villages at the relevant time. Both our high schools have been informed and PCSOs have given words of advice within school assemblies.

Hemsby is also on a tasking operation claw in regards to ASB in the village, criminal damage and violent behaviour.

There are plans for a third AND FINAL Christmas Tree to be erected in St Mary's Close. This will be discussed with St Marys Close, the PC and general permission will have to be granted by all parties before this is launched to the public.

Parish Council Brooks gave the following report:

Update to Hemsby PC Monday 21st March 2011.

Project Delivery.

All 8 projects are now either committed, funding allocated or events planned. It is requested that cheques be made available between PC meetings to meet the planned expenditure as below. The group chair (L.Brooks) will authorise all such payments to the Parish Clerk.

Project by project summary.

1. Community Hub. The Hub will be based in the Pavilion. New furniture and storage has been ordered. BT line required for a WiFi connection. This requires PC go ahead. *After discussions it was agreed this would be left with the HPFMC to deal with, there will be no involvement with the PC.*
Coffee machine, cups and notice board to be obtained.
A block booking of the Pavilion to be provided for Community group usage.
2. Youth Offer. Work is progressing well with the new Hemsby Young People's Group. The budget of £3,000 will be committed to equipment, training, hiring fees and the cost of specific events / outings. A venue for this group is potentially the Community Hub. Delay is due to bank account problems for the Youth Group.
3. Community Purchasing Scheme. Meeting held at the school explaining the NRCC Oil scheme. Registrations now being taken. Once registered individuals can telephone in and make an order. Also covers bottled Propane gas. The £30 ~~fee~~ registration fee for the village has already been paid from funding.
4. Village Games. The plan is to look to enter a team in the Norfolk Village Games on June 19th. Sampler sessions including a taster day to be held on 7th May. Zumba dancing taster session planned for 25th March. Budget £1,000.
5. Dog Waste Bins. Funding for 2 /3 new general waste bins with labelling regarding the placement of dog waste. Budget £1,000. Borough Environmental Wardens to also be engaged in the scheme. Bins to be purchased.
6. Arts & Crafts. A series of samplers for various Art & Craft activities. Requires firming up of the options. Potentially to run in the Community Hub.
7. Barn Room Improvement. The scheme will support the improvement to facilities at the Barn Room, in the form of enhanced heating, insulation and kitchen facilities. Spend of £2350 awaiting the release of the capitol monies from GYBC.
8. Community Re-Cycling. A notice board to be erected on the Post Office wall with offers from villagers of items for free use by others. Costs notice board and planning permission circa £450. Await GYBC planning permission.

- **Anglia Water meeting held on 14 February 2011 at the Great Yarmouth Borough Council Town Hall notes**

Anglia Water representatives commented that this was a particularly low lying area around the pumping station in Yarmouth Road. There had been a number of maintenance issues at Yarmouth and these were currently being investigated. Anglia Water stated their commitment to refurbish the Hemsby main Yarmouth Road pumping station this calendar year.

The Anglia Water representatives commented that the company needed to prioritise what schemes they could carry out within the budget available and to also carry out schemes that were most beneficial to their customers. The representatives reported on the need to obtain details and evidence from Hemsby Parish Council with regard to the issue of lack of capacity in the Hemsby Parish area.

The Hemsby Parish Council representative reported that the Hall Road dyke discharges into the Broad and that this affects the drinking water supply. The representative also reported that there had been two issues since December with regard to problems in relation to the pumping station. In particular, reference was made to the problems of the Hemsby Post Office whose basement floods where perishable goods are stored.

The Liaison Group also discussed the proposed development of housing at the former Pontins site and the likely affect this could have on the sewerage system. The Liaison Group noted that there needed to be closer liaison with Anglia Water with regard to the provision of large housing developments in the Borough.
