- Anglia Water sewerage flooding

A meeting was held at the Parish Office with Vice Chairman of the PC, residents who had been affected on the 20 March 2011, AW representatives and the Borough Councillor Weymouth to discuss all the problems that the parishioners are experiencing and how they could be resolved.

Aw sewerage problems at the Pumping Station in Yarmouth 13/4 14/4 & 15/4 due to a power surge.

The pumps in the Yarmouth Road Pumping Station are to be changed – they have been ordered but it will take around twelve weeks for the order to come thro – so they are saying August 2011.
